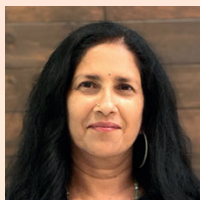

### Opening keynote

### Access to Justice and Human Rights – Current state of Access to Justice and Global Movement

**Sushma Raman**

*Social Change Strategist (USA)*

Sushma Raman is a seasoned human rights practitioner and social change strategist with over two decades of experience designing and leading innovative programs at prominent foundations and NGOs, including the Ford Foundation and Open Society Foundations. She has also taught at leading universities, serving as executive director of Harvard's Carr Center for Human Rights Policy from 2015 to 2023. Currently, Sushma advises philanthropic and NGO leaders as a strategic consultant and serves as the interim executive director of Greenpeace USA. She is the coauthor of two influential books: *The Coming Good Society: Why New Realities Demand New Rights* (Harvard University Press, 2020) and *Holding Together: The Hijacking of Rights in America and How to Reclaim Them for Everyone* (New Press, 2022).

**Rosalie Silberman Abella**

*Retired Justice of the Supreme Court of Canada, Professor at Harvard University (Canada)*

The Honorable Rosalie Silberman Abella served as a Justice of the Canadian Supreme Court for 17 years, retiring in 2021 upon reaching the mandatory age. She was the first Jewish woman and the first refugee appointed to the Canadian judiciary. Justice Abella began her career in civil and criminal litigation before her historic appointment to the Ontario Family Court in 1976 at just 29 years old, becoming the first pregnant woman to join the bench. She went on to chair the Ontario Law Reform Commission and the Ontario Labour Relations Board. In 1984, she served as the sole Commissioner and author of the Royal Commission on Equality in Employment, where she coined the term and developed the concept of "employment equity." Her definition of equality in the Commission's Report was later adopted by the Supreme Court of Canada in its first ruling interpreting the equality provision of the Canadian Charter of Rights and Freedoms. Justice Abella is a Lifetime Fellow of the Royal Society of Canada and has been elected to both the American Academy of Arts and Sciences and the American Philosophical Society. A graduate of the Royal Conservatory of Music in classical piano, she has judged the Giller Literary Prize and authored or co-edited four books and over 90 articles on various legal topics. She holds 42 honorary degrees and is currently the Samuel and Judith Pizar Visiting Professor at Harvard Law School. She was married to renowned Canadian historian Irving Abella from 1968 until his passing in 2022. Together, they have two sons, Jacob and Zachary, both of whom are lawyers.

Luís Roberto Barroso assumed the presidency of the Federal Supreme Court and the National Justice Council in September 2023, after being appointed to the Court in 2013. In addition to his judicial responsibilities, he is a Full Professor of Constitutional Law at the State University of Rio de Janeiro and serves as a Senior Fellow at Harvard Kennedy School. Barroso is the author of several books on Constitutional Law and has published numerous articles in both Brazilian and international journals. His academic credentials include a Master of Laws (LL.M.) from Yale Law School, a doctorate from the State University of Rio de Janeiro, and postdoctoral studies at Harvard Law School. Prior to joining the Court, he practiced law for 30 years.

Felipe Freitas, a native of Bahia and born in Feira de Santana, holds a PhD and a Master's degree in Law from the University of Brasília (UNB) and earned his Law degree from the State University of Feira de Santana in 2010. He previously served as director of Plataforma Justa, an organization focused on studying and providing information about the financing and management of the justice system, and as coordinator of Rede Liberdade Programs. Freitas is a contributing professor in the Professional Master's Program in Public Security at the Federal University of Bahia (Progesp-UFBA) and a permanent professor in the Postgraduate Program in Constitutional Law at the Brazilian Institute of Education, Development, and Research (IDP). 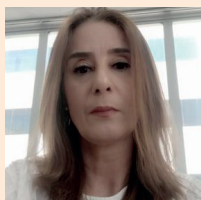
*Gender and Race Analyst at UNDP*

An Indigenous woman from the Pataxó people of Bahia, she is a member of the Network of Indigenous Women of Bahia – Daughters of Ancestry. She is currently a Master's student in Ethnic and African Studies (POSAFRO/UFBA) and is pursuing a degree in Law at the Federal University of Bahia (UFBA).

She also holds a degree in Economic Sciences from UFBA (2014), where she conducted research on the social, political, and productive organization of the Tupinambá of Serra do Padeiro (Tupinambá de Olivença Indigenous Land, Bahia). She is a specialist in Human Rights and Contemporaneity from the UFBA Law School (2020) and in Rights and Policies for Indigenous Peoples from the PUC-Rio Law Institute (2024). Currently, she serves as the Executive Coordinator of the National Association for Indigenous Action (ANAI), where she previously held the role of Vice-President (2019–2021). She also coordinates the Jenipapo Urucum and Raízes da Terra projects. Additionally, she is a member of the State Council for the Sustainability of Traditional Peoples and Communities (CESPCT) (2022–2024) and serves as Deputy Ombudsperson for the Public Defender's Office of Bahia (2023–2025).

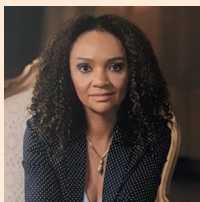


## Wallace Corbo

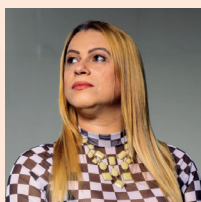

*Journalist and National Secretary for the Rights of LGBTQIA+ People*

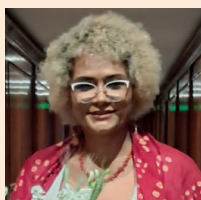
Symmy Larrat is a transvestite, feminist, and activist for LGBTQIA+ rights. She currently serves as the National Secretary for the Rights of LGBTQIA+ People at the Ministry of Human Rights and Citizenship. Throughout her career, she has held significant leadership roles, including serving as president of the Brazilian Association of Gays, Lesbians, Bisexuals, Transvestites, Transsexuals, and Intersex People (ABGLT), the oldest LGBTQIA+ organization in Brazil. She has also held prominent public positions, such as Deputy Coordinator for the Promotion of LGBT Rights under President Dilma Rousseff's administration and Coordinator of the Transcidadania Program in São Paulo City Hall during Mayor Fernando Haddad's tenure. The Transcidadania Program was the first intersectional public policy initiative for transgender people in Brazil and received international recognition.

Specialist in Rule of Law Policies at UNDP, focusing on Justice, Citizen Security, and Human Rights for Latin America and the Caribbean. 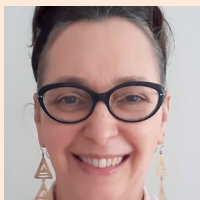

*Director SUPRAD/BA*

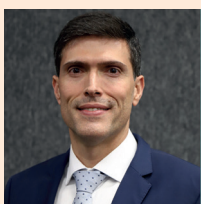

#### **Mediation - Pablo Coutinho Barreto**

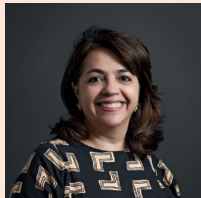

Sineia Bezerra do Vale, from the Wapichana people, serves as the Coordinator of the Department of Territorial and Environmental Management (DGTA) at the Indigenous Council of Roraima (CIR). She is a Master's student in Sustainability with Traditional Peoples and Territories at the University of Brasília (UnB) and also coordinates the Indigenous Climate Change Committee (CIMC). In 2021, Sineia was the only Brazilian to address the global community about the struggles of Indigenous peoples against environmental and territorial destruction when she participated in the Leaders' Summit on Climate in the United States. Her advocacy and leadership have earned her numerous awards, including the Women Who Make a Difference award from the U.S. Embassy and Consulate, the Romy Trophy from the School of Judiciary of the State of Rio de Janeiro (EMERJ), recognizing five of the most active women in 2023, and the title of Indigenous Scientist in Brazil, awarded by Planetary Guardians in May 2024.

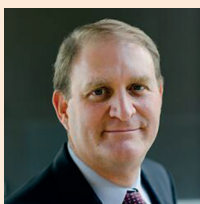
**Mediation - Patricia Perrone**

### Regulatory Challenges for AI in the Protection of Human Rights

**Nate Persily**

*Stanford Professor - (USA)*

Nate Persily is the James B. McClatchy Professor of Law at Stanford Law School, with joint appointments in the departments of Political Science and Communication. He is the founding codirector of the Stanford Cyber Policy Center and its Program on Democracy and the Internet. His scholarship focuses on the “Law of Democracy,” addressing topics such as voting rights, political parties, campaign finance, redistricting, and election administration. He has served as a special master or court-appointed expert in crafting congressional or legislative districting plans for several states and as the Senior Research Director for the Presidential Commission on Election Administration. Persily is a coauthor of the leading election law casebook, *The Law of Democracy*, and coeditor of *Social Media and Democracy* and *The Digitalist Papers: Artificial Intelligence and Democracy in America* (2024). His current research, for which he has been honored as a Guggenheim and Andrew Carnegie Fellow, examines the impact of evolving technology on political communication, campaigns, and election administration.

Luís Roberto Barroso assumed the presidency of the Federal Supreme Court and the National Justice Council in September 2023, after being appointed to the Court in 2013. In addition to his judicial responsibilities, he is a Full Professor of Constitutional Law at the State University of Rio de Janeiro and serves as a Senior Fellow at Harvard Kennedy School. Barroso is the author of several books on Constitutional Law and has published numerous articles in both Brazilian and international journals. His academic credentials include a Master of Laws (LL.M.) from Yale Law School, a doctorate from the State University of Rio de Janeiro, and postdoctoral studies at Harvard Law School. Prior to joining the Court, he practiced law for 30 years.

Elisa Calcaterra was appointed as Deputy Resident Representative (DRR) of the United Nations Development Program (UNDP) for the Federative Republic of Brazil, assuming the role on July 30, 2024. From 2021 to 2023, she led the Program and Operations Unit at the UNDP Center in Rome, Italy.
